APPLICATION FOR BOAT PARKING ON DINGHY SPACES OR CANOE RACKS

AT THE CREEK LAWN, FROGMORE

PRECEDENCE WILL BE GIVEN TO RESIDENTS OF FROGMORE AND SHERFORD PARISH

TERMS AND CONDITIONS

1. All owners must comply with the conditions set out below
2. All small boats must be marked with their name or the fact that they are a tender to a larger craft.
3. Spaces in the aforementioned facilities are only for the agreed and specified vessel and are not to be used by any other craft. THIS IS NOT A VEHICULAR PARKING SPACE
4. All boats must also display their current Harbour Dues plaque. Unmarked boats may be regarded as unauthorised and removed.
5. Halyards, sheets and stays should all be securely fastened in such a way that they cannot flap against the mast or boat and cause a nuisance.
6. All boats should be placed within their marked dinghy space or canoe rack, and clear of any access to the pathways or slipways. To secure the boats against strong winds, all boats must be fastened securely at all times to the fittings provided on both the rack and the dinghy spaces. Small boats on the dinghy spaces should be kept on a trailer/trolley to allow for ease of site maintenance.
7. Boats are left at their owner's risk. The Parish Council disclaims any responsibility for theft, loss or damage caused to boats or parts thereof, or their contents.
8. The Parish Council may remove boats left without payment of the appropriate charge and will not be liable for any damage caused whilst so removing any boat or gear.
9. Permit Fees. The following fees will apply (2026/27)

Canoes/Kayaks on rack £30pa

Dinghy spaces on lawn £75pa

A permit is personal to the purchaser only. It cannot be transferred, assigned, sub-let, or hired out or loaned to another person for any period of time.

The period of licence for the space will be from 1st April to 31st March. Owners may be asked to move the boats in the dinghy spaces on rare occasions to allow the Lawn to be used for other Parish events.

10. For Health and Safety reasons, the Parish Council cannot allow boats which do not fit on to the dinghy spaces provided. Maximum length 3.60m (approx. 12 foot) and maximum width 1.70m (approx. 5 foot 6 inch). This to include any trailer and/or outboard motor.
